This is a summary of the Annual Report for the Pension Plan for Nursing Home & Health Care Employees – Philadelphia and Vicinity, Employer Identification Number 23-2774706, Plan No. 001 for the year ended December 31, 2015. This Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust fund and are funded with contributions to the Fund by contributing employers and by investment earnings.

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$48,242,094 as of December 31, 2015 compared to \$46,140,825 as of January 1, 2015. During the plan year, the plan experienced an increase in its net assets of \$2,101,269. This increase includes unrealized appreciation or depreciation in the value of the plan's assets; that is, the difference between the value of the plan's assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$4,273,854 including employer contributions of \$3,726,914, earnings from investments of \$494,677 and other income of \$52,263.

Plan expenses were \$2,172,585. These expenses included \$271,697 in administrative expenses and \$1,900,888 in benefits paid to participants and beneficiaries. A total of 8,039 persons were participants in or beneficiaries of the plan at the end of the plan year.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the Plan, whose address is set forth above, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
