For the service to be submitted as a claim, the participant must be an active Independence health plan member and present their member ID card.

- When is the earliest that a group can participate in the flu shot program?
- Can you also provide the COVID-19 vaccine (if interested)?
- What is the lead time required for scheduling an onsite flu shot clinic?
- Do you offer an online scheduler for flu shots?
- Do you have a cancellation policy? What should my company do if they need to cancel a scheduled flu shot clinic?
- Are there any cancellation fees?
- Are there any restrictions regarding who can receive a flu shot?

- What is the cost of the flu shot for non-Independence members? What are the payment options for flu shots for non-Independence members?
- Are there any additional costs to host an onsite flu shot clinic?
- When and why would my company receive an invoice?
- · Will my company be charged for any unused doses?
- How many shots can be administered per hour?
- Will you bring extra doses to the flu shot clinic site?
   If so, how many?
- Do you need access to Wi-Fi (or can the company provide it)?
- Are there any spacing guidelines for set up?
